

Regional Trade Statistics (RTS): Revisions to Data Quarter 1 2013

Application of unscheduled revisions to RTS

Following routine quality assurance and checking procedures, Trade Statistics has identified some significant missing and incorrect declarations in certain commodity codes.

Given the scale and the impact of the changes on trade statistics, HMRC have revised the trade figures for 2008, 2009, 2010 and 2011. The revisions to the Overseas Trade Statistics (OTS) were released on 10 May 2013 for [Non-EU trade](#) and 14 May 2013 for [EU trade](#) in line with the UK Statistical Authority Code of Practice for Official Statistics and the HMRC Trade Statistics Revision Policy.

The Quarter 1 2013 RTS release has been revised to incorporate these revisions.

Further revisions to RTS due to a processing error

The Quarter 1 2013 RTS release also includes some further large scale revisions that have been made to correct a processing error that has affected the regional distribution of trade. All RTS data from 2008 onwards has been revised to correct this error. The error had predominantly resulted in EU trade for a large number of business branches being incorrectly placed in the 'Unknown' region, rather than being allocated to the region of the main reporting unit of the business where possible. The error has also resulted in a small amount of EU and non-EU trade being allocated to incorrect regions. The effect of the change is:

- A large amount of EU trade that was previously allocated to the Unknown region is now allocated to the region where the main reporting unit of the business is located;
- A small amount of trade (both EU and non-EU) that was previously allocated to an incorrect region is now allocated to the region where the main reporting unit of the business is located.

The total effect of the revisions by region is detailed in Tables 1-24:
